NOTICE MADE BY HIS EXCELLENCY THE GOVERNOR UNDER CERTAIN SANCTIONS REGULATIONS AS MODIFIED BY CERTAIN OVERSEAS TERRITORIES SANCTIONS ORDERS TO DELEGATE (AND AUTHORISE THE DELEGATION OF) CERTAIN POWERS AND FUNCTIONS UNDER THOSE SANCTIONS REGULATIONS AND TO AUTHORISE PERSONS TO EXERCISE (AND AUTHORISE THE EXERCISE OF) CERTAIN POWERS CONFERRED BY THOSE SANCTIONS REGULATIONS AND FOR CONNECTED PURPOSES

WHEREAS the United Kingdom Statutory Instruments listed in the first column of Parts 1, 2 and 3 of Schedule 1 to this Notice ("the Sanctions Regulations") have been extended with modifications to the Virgin Islands by the Orders-in-Council listed in the second column of Schedule 1 ("the Overseas Territories Sanctions Orders");

WHEREAS the Sanctions Regulations may be amended or modified to include new provisions having equivalent effect to provisions of other Sanctions Regulations;

WHEREAS United Kingdom Statutory Instruments ("New Sanctions Regulations") containing provisions having equivalent effect to provisions of the Sanctions Regulations may be made in the United Kingdom under powers given by provisions of the Sanctions and AntiMoney Laundering Act 2018 (UK 2018 c.13) as amended or replaced from time to time, and the New Sanctions Regulations may be extended with or without modifications to the Virgin Islands by Order-in-Council;

WHEREAS every reference in this Notice to a provision in the Sanctions Regulations or in New Sanctions Regulations is to be construed as a reference to that provision as amended or replaced from time to time, to the extent for the time being that it applies in the Virgin Islands, and as modified from time to time in its application in the Virgin Islands;

WHEREAS the Overseas Territories Sanctions Orders have modified the Sanctions Regulations in their application in the Virgin Islands, *inter alia*, by inserting, as regulation 4A(2) of each of the Sanctions Regulations, a provision giving the Governor the power to delegate powers under the Sanctions Regulations to any person or any class or description of persons or to authorise the delegation of those powers;

WHEREAS, if a provision in New Sanctions Regulations has equivalent effect to a provision in the Sanctions Regulations and a power under the provision in the Sanctions Regulations is delegated by this Notice, then the power under the corresponding provision in the New Sanctions Regulations is to be treated as also having been delegated in the same way;

WHEREAS, if, at the time when this Notice is issued, a provision in the Sanctions Regulations or in New Sanctions Regulations has not yet been modified to give a power under

that provision to the Governor, any delegation of that power in this Notice will take effect at such later time (if any) when the provision is modified to give it to the Governor;

WHEREAS every reference in this Notice to regulation 4A(2) of each of the Sanctions Regulations is also to be taken to include a reference to a provision in New Sanctions Regulations (whether or not numbered in the same way) giving the Governor a power to delegate powers or to authorise the delegation of those powers;

WHEREAS the Sanctions Regulations were modified by the Overseas Territories Sanctions Orders, *inter alia*, by renumbering the existing text of regulation 2 of each of the Sanctions Regulations to become regulation 2(1) and inserting in regulation 2(1) a definition of "authorised officer" to mean, *inter alia*, a person authorised by the Governor for the purposes of exercising, whether generally or in a particular case, certain specific investigative and enforcement powers under the Sanctions Regulations, and also to mean, *inter alia*, any person acting under the authority of a person so authorised by the Governor;

WHEREAS, by a Notice (Statutory Instrument 2023 No.53) made on 16 May 2023 and gazetted on 18 May 2023 ("the 2023 Notice"), the Governor authorised the Director of the Financial Investigation Agency to be an authorised officer for the purposes of exercising any or all of the powers conferred by the regulations listed within subparagraph (c) in the definition of "authorised officer" in regulation 2(1) of each of the Sanctions Regulations and also gave notice that, in accordance with subparagraph (d) of that definition, any person acting under the authority of the Director of the Financial Investigation Agency is also an authorised officer for the purposes of exercising, under that authority, any or all the powers conferred by the regulations listed within subparagraph (c) in the definition of "authorised officer" in regulation 2(1) of each of the Sanctions Regulations;

WHEREAS, if a provision in New Sanctions Regulations has equivalent effect to a provision in the Sanctions Regulations and a person is authorised, by or under this Notice or the 2023 Notice, to exercise a power under the provision in the Sanctions Regulations, then that person is to be treated as also having been authorised to exercise that power under the corresponding provision in the New Sanctions Regulations in the same way;

AND WHEREAS every reference in this Notice to the definition of "authorised officer" in regulation 2(1) of each of the Sanctions Regulations is also to be taken to include a reference to a provision in New Sanctions Regulations (whether or not numbered in the same way) giving the Governor power to authorise persons to exercise powers or for those acting under the authority of a person so authorised also to be authorised officers for the purpose of exercising those powers;

NOW THEREFORE I, DANIEL PRUCE, Governor of the Virgin Islands, **GIVE NOTICE** that in accordance with regulation 4A(2) of each of the Sanctions Regulations, I:

- (a) delegate to the Attorney General,
 - (i) the powers to receive applications for (and information relating to) the grant or variation of a director disqualification licence, a financial sanctions licence or a trade licence to be issued by the Governor (with the consent of the Secretary) under any of the provisions listed in Part 1 of Schedule 2 (or provisions in New Sanctions Regulations having equivalent effect to one or more of those provisions); and

- (ii) the powers to receive reports made under any of the provisions listed in Part 2 of Schedule 2 (or provisions in amended Sanctions Regulations or in New Sanctions Regulations having equivalent effect to one or more of those provisions);
- (b) delegate to the Director of the Financial Investigation Agency and the Managing Director of the Financial Services Commission,
 - (i) the function of publishing lists of designated persons (and keeping those lists up to date) in accordance with each of the provisions listed in Part 1 of Schedule 3 (and in accordance with any provisions in New Sanctions Regulations having equivalent effect to one or more of those provisions);
 - (ii) the function of publishing lists of designations by description (and keeping those lists up to date) in accordance with each of the provisions listed in Part 2 of Schedule 3 (and in accordance with provisions in amended Sanctions Regulations or in New Sanctions Regulations having equivalent effect to one or more of those provisions); and
 - (iii) the power to determine for the purposes of regulation 8(3) of each of the Sanctions Regulations listed in Part 1 of Schedule 1 and regulations 8(3) and either 9A(3) or 12(3) (as the case may be) of the Sanctions Regulations listed in Part 2 of Schedule 1 (and for the purposes of provisions in amended Sanctions Regulations or in New Sanctions Regulations having equivalent effect to regulation 8(3), regulation 9A(3) or regulation 12(3), whether or not numbered in the same way), what method or methods are to be considered appropriate for the publication of those lists;
- (c) authorise the Attorney General, the Director of the Financial Investigation Agency and the Managing Director of the Financial Services Commission to designate other officers to exercise some of all of their powers and functions and to delegate any of those powers and functions to officers so designated, to such extent and subject to such restrictions and conditions as they deem proper;
- (d) authorise the Director of the Financial InvestigationAgency (to the extent not already authorised by the 2023 Notice),
 - (i) in accordance with subparagraph (c) in the definition of "authorised officer in regulation 2(1) of each of the Sanctions Regulations, to be an authorised officer for the purpose of exercising any or all of the powers conferred by regulations listed in those subparagraphs (and by regulations in amended Sanctions Regulations or in New Sanctions Regulations having equivalent effect to one or more of the regulations listed in those subparagraphs); and
 - (ii) in accordance with subparagraph (d) in the definition of "authorised officer in regulation 2(1) of each of the Sanctions Regulations, to authorise other persons to exercise any or all of the powers

aforementioned in (d)(i) above under their authority, so that any person acting under that authority is an authorised officer for the purposes of exercising those powers under that authority;

- (e) authorise the Attorney General,
 - (i) in accordance with subparagraph (c) in the definition of "authorised officer" in regulation 2(1) of each of the Sanctions Regulations, to be an authorised officer for the purposes of implementing, monitoring compliance with and detection of sanctions by exercising powers to Request Information; powers regarding General Trade Licences: Inspection of Records; powers to Disclose Information, as conferred by regulations listed in those subparagraphs (and by regulations in amended Sanctions Regulations or in New Sanctions Regulations having equivalent effect to one or more of the regulations listed in those subparagraphs); and
 - (ii) in accordance with subparagraph (d) in the definition of "authorised officer in regulation 2(1) of each of the Sanctions Regulations, to authorise other persons to exercise the powers aforementioned in (e)(i) above under their authority, so that any person acting under that authority is an authorised officer for the purposes of exercising those powers under that authority;
- (f) authorise the Attorney General to implement and enforce General Licences subject to the approval of the Governor and consent of the Secretary of State;
- (g) authorise the Attorney General to coordinate the publication of Overseas Territories Sanctions Orders.

I reserve the right to vary or revoke this authorisation at any time, as I may deem appropriate given the circumstances.
